MSAD#1 PRE-K REGISTRATION FOR SCHOOL YEAR 2020-2021

MSAD#1 will begin accepting **Pre-K students for the Fall of 2020**. All MSAD#1 children who are four years old on or before October 15, 2020 are eligible for enrollment.

DETAILS ABOUT OUR NEW ON-LINE REGISTRATION PROCESS

Parents and Guardians are now required to complete a New Student Registration on-line prior to our Registration Meetings. The link to do this will open on February 24, 2020 and may be found on MSAD#1's Home Page: www.sad1.org

Parents and Guardians will also be required to attend Registration Meeting as listed below. At this time, there will be a brief introduction to MSAD#1's Pre-K Program.

After the introduction to the Pre-K Program, you will meet with one of the school nurses in order to review your child's health needs, immunization status, and registration information. Meeting with the school nurses will complete the registration process for your child unless further information is required.

- For children in the **Mapleton** area:

- For children in the **Presque Isle** area:
Meeting Place: Pine Street School
Meeting Date/Time: Wednesday, March 25 at 6:00 PM

MSAD#1 requires the following documentation at the time of registration.

Please bring these items with you to the *Registration Meeting*:

1. Proof of Immunization
2. Legal Birth Certificate (from the town or city in which the child was born)
3. Legal Guardianship/Custody Papers
4. Parent/Guardian Photo Identification
5. Proof of residency within MSAD#1 (utility bill, lease agreement, etc.)
